CONTINUING EDUCATION CREDITS • Students qualify for up to 129 hours of CPEs upon completion of all three sessions. The first year qualifies for up to 43 hours, the second year qualifies for up to 44 hours, and the third year qualifies for up to 42 hours. Students can also qualify for up to 37 CLE per year.

ADMISSION

Applicants must be high school graduates with a minimum of two years of banking experience prior to attending the first session. Two years or more of college may be substituted for one year of banking experience. Applicants should be familiar with basic accounting practices.

All students must be an employee or director of a bank or approved financial institution, employed by a regulatory agency, or an associate member of the Alabama Bankers Association.

REQUIREMENTS TO GRADUATE:

- Successfully complete three home study projects between sessions.
 - Applicants should consider this aspect of the school to ensure they will be able to devote the necessary time outside the classroom.
- Successfully complete comprehensive exams at the end of both the first and second sessions.
- Fully participate in all assigned classes and required networking events.

TUITION

Admission deadline is September 12. Tuition includes all instruction and course materials through Canvas, an online learning management system, as well as daily breakfast, refreshment breaks, and coffee each morning. A Wifi enabled tablet or laptop with a note taking app is required to view presentations and assignments during class.
